Joseph, who we shared with you in the January Newsletter, came into the children's home in 2006.

He was 5 years old. We had no idea he had a heart condition. When his heart condition was discovered we took him to the doctors office; unfortunately he was diagnosed with lymphoma. Jospeh had heart surgery in hopes of bringing some healing to his condition. However, early this month of September, Joseph left our arms to be in the arm of his Lord and Savior Jesus Christ. While we are sad to not have him here with us we rejoice with him that he is no longer sick or in any pain because he is in Heaven, running and playing like he was unable to here on this earth.

Morgan, who we shared about in the January Newsletter as well, was playing with his friends in the children's home when a stick injured his left eye. We took him to the hospital immediately. He had an operation, but still he could not see. He had been going frequently to the doctors for check ups. The doctor said that this is something that possibly could be fixed in due time with the right medical attention. After some time the doctors decided that the only safe solution was to remove the damaged eye so that it





would not cause infection or create further damage to his good eye. After the surgery Morgan is still in recovery yet is still at risk. We ask that you continue to pray for Morgan and for his future.

One of our board members for Bungoma Bible Ministries recently had pulmonary embolisms (which means that blood clots where found in his lungs). He was taken to the hospital for immediate care. He is doing better now and is under the doctors care to receive further monitoring. Please keep our Bungoma Bible Ministries team in your prayers.
